The Anna R. Prescott Distinguished Member Award

Eligibility Requirements: Members of the Louisiana Association for Healthcare Quality who have maintained current membership for a two year period and meet some of the following requirements.

Purpose: To encourage and honor a member of the Louisiana Association for Healthcare Quality who has contributed to the Association and is regarded as an expert in the field of healthcare quality, or related fields such as: case management, risk management, information management, or infection control in Louisiana.

Criteria for Submission

Eligibility: Members of the Louisiana Association for Healthcare Quality who have maintained current membership for a two year period and meet the following requirements.

2. REQUIREMENTS

a. Service to the Association:

(1) Has served the Regional Association participation, as an officer, chairman and/or committee member within the past 10 years.

(2) Has served the State Association participation as an officer, committee chairman, committee member and/or delegate/alternate delegate to the Leadership Council of the National Association for Healthcare Quality within the past 10 years.

(3) Individuals who have promoted the Association by service as a chairman or as a member of a committee(s); promoting membership, mentor of fellow professionals, and one who is always available for consultation or assistance to the state or region(s).

c. Education leadership:

(1) Presenter or co-presenter related to healthcare quality topic at regional, state, or national workshops, seminars or conferences with the past 10 years.

(2) Instructor or co-instructor on healthcare quality topic for an in-service training program(s) within the past 10 years.

d. Contribution to expand the body of knowledge:

(1) Candidate has developed innovative approaches related to healthcare quality, utilization, risk management, patient safety, infection control, or case management within the past 10 years.

(2) Candidate has shared knowledge and expertise with other healthcare quality, utilization, risk management, patient safety, infection control, or case management professionals within the past 10 years.

e. Certification:

Candidate is currently certified by a certification agency such as the Healthcare Quality Certification Board as a CPHQ, Case Management-CCM, CPUR/UM , ASHRM-American Society of Healthcare Risk Management, DID-Certification in Infection Control or any other healthcare certification board.

6. Nomination Form & Award Questionnaire Form:

a. Nominations for the Anna R. Prescott Distinguished Member Award will be accepted for any member in good standing. Self-nominations are acceptable.

b. A nomination form (attachment I) must be submitted for each nominee.

c. Each candidate will complete an Award Questionnaire Form, and return it to the Awards Selection Team Chairman by the date designated on the form..

d. Chairman will distribute the Award Questionnaire Form to the Award Team Members for their use in determining the award recipient based on predetermined criteria.
